<u>Distinguishing Features of the Class</u>: This is routine work requiring an experienced electronic technician and consists of erection, installation and maintenance of all overhead and underground electric signal lines. Work requires the use of lift equipment in all kinds of weather conditions and rigid observance of safety precautions to prevent injury to assistants and bystanders. Broad instructions are received from superiors. Linemen also assist in maintenance of all signal equipment. Work is seldom reviewed in process but is always checked on completion. Supervision <u>is</u> exercised over assistants/laborers. Does related work as required.

Required Knowledge Skills and Abilities: Thorough knowledge of the theory and principles of electricity, and electrical signal distributing systems; thorough knowledge of standard safety measures, devices and precautions in the handling of electric circuits; ability to use the tools and equipment of the trade; ability to follow oral and written directions; steady nerves; physical strength and stamina to perform arduous manual labor and to withstand adverse weather conditions; ability to plan daily duties; ability to keep records and prepare reports; ability to get along well with others; willingness to work outdoors, occasionally under adverse weather conditions; mental alertness; initiative; good judgment; physical strength; good physical condition. Physical condition commensurate with the demands of the position.

<u>Minimum Qualifications</u>: Graduation from High School or possession of a High School Equivalency Diploma issued by the New York State Department of Education and two (2) years of experience as a lineman or technician in power and signal distribution systems or a similar field.

A valid NYS Drivers License is required at the time of appointment and must be maintained throughout employment.
