## MECHANIC – PARKS DEPARTMENT

**Salary:** \$18.04 - \$20.20 per hour

**Classification:** CSEA, Non-Competitive Position  
Membership in the NYS Retirement System is Mandatory  
Eligible for Health and Dental Insurance

**Distinguishing Features of the Class:** This position is responsible for the maintenance of a variety of automotive and related equipment, including automobiles, trucks, buses, and construction equipment. Duties are performed under general supervision of a higher ranking employee with allowance made for the exercise of independent judgment in carrying out the details of the work. Supervision may be exercised over the work of laborers or other assistants. Does related work as required.

**Examples of Work:**

Performs skilled repairs to motor equipment, including automobiles, diesel trucks, tractors, lawn mowing equipment, and small engines;  
Grinds valves and fits new bearings, pistons, and rings;  
Repairs or replaces motors, pumps, alternators, carburetors, shock absorbers, tires, etc.;  
Repairs ignition systems, transmissions, brake systems, clutches, and front and rear axles;  
Estimates the need for and orders spare parts, tools, and supplies;  
Adjusts connecting rods and bearings;  
Adjusts steering mechanisms and aligns wheels;  
Makes welding repairs to automotive and related equipment;  
Assembles and tunes engines and sets timing;  
Greases vehicles, changes oil and filters;  
Sharpens tools as necessary;  
Makes service calls to repair road breakdowns;  
Attaches and removes snow plow blades and other auxiliary equipment;  
May operate machine shop equipment, including lathes, grinders, drill presses, and other metal working machines to make and repair parts for automotive equipment;  
May perform necessary tasks to insure that vehicles conform to State Department of Transportation inspection requirements and maintains related log;  
Repairs small gasoline engines;  
May arrange for mandatory State vehicle inspections as necessary.  
Performs a variety of related duties as necessary.

**Minimum Qualifications:**

One (1) year of experience in the repair of automotive equipment as well as a valid Commercial Driver's License issued by the State of New York.

**SPECIAL REQUIREMENT:**

Candidates must possess a valid Commercial Driver's License issued by the State of New York and maintain a valid license throughout employment.
