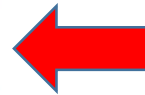

IF YOU ARE ATTEMPTING TO PAY A BILL, CLICK THE “PAY SELECTED INSTALLMENTS” TAB. IF THE BILL YOU ARE PAYING HAS MULTIPLE INSTALLMENTS, THEY MUST BE PAID IN ORDER AND YOU CAN PAY MORE THAN ONE BY CLICKING THE BOXES NEXT TO THE DESIRED INSTALLMENTS. IF YOU WANT TO PAY TAX LIENS, ALL LIENS MUST BE PAID IN THE **SAME** TRANSACTION. IF YOU WANT TO PAY LIENS INDIVIDUALLY, YOU CAN COME TO THE CITY COMPTROLLER’S OFFICE OR CONTACT US AT THE NUMBERS PROVIDED ON THE WEBSITE.

AFTER CLICKING “Add Selected Installments to Cart,” YOU CAN REVIEW THE ITEMS IN YOUR CART BY CLICKING THE “MY CART” TAB IN THE UPPER RIGHT CORNER.

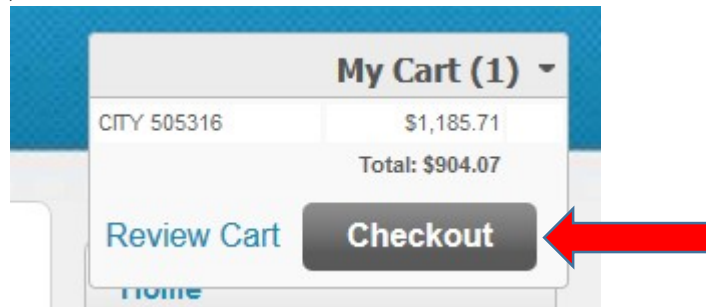
