ITEM # 1 Approval of Agency Minutes

ITEM #2 1220 Capital Avenue

Sale of 1220 Capital Avenue to Jose Gomez on July 16, 2015 was rejected by the Common Council on September 2, 2015. The property was put back on the market for resale on September 4, 2015. An offer was received from Jose Gomez in the amount of \$4,000.00 for the property located at 1220 Capital Avenue. The bidder plans to renovate for primary residence. A second offer was received from Bridge Brook Partners LLC in the amount of \$9,000.00 to renovate for income property. A third offer was received from Nidia Heredia Rivera in the amount of \$7,000.00 to renovate for primary residence. A fourth offer was received from Johnny Paredes and Luisa Carrasco in the amount of \$7,500.00 to renovate for primary residence. A fifth offer was received from Carmen Alvarez in the amount of \$8,000.00 to renovate for primary residence.

Dave Farina made a motion to review the sale of this property in Executive Session. The motion was seconded by Mike Mahoney and passed unanimously. After review, Mike Mahoney made a motion to designate Jose Gomez as an eligible project sponsor for the redevelopment of 1220 Capital Avenue contingent that the bidder raise their bid to \$7,000 and with the condition that all applicable codes are complied with and any necessary permits are obtained for work to be completed on the property. The motion was seconded by Dave Farina and passed unanimously.

An offer was received from Amalia Gasparotti in the amount of \$2,000.00 for the properties located at 324 South Street. The bidder plans for renovate for primary residence.
