ITEM #1 Approval of Agency Minutes

ITEM #2 URA Budget FY: 2017-2018

Board members received the Utica Urban Renewal Agency budget for fiscal year 2017-2018 for review at the March 9, 2017 meeting. The item was tabled for two weeks to allow members time to review it.

The first transfer in the amount of \$6,117.50 from Other Equipment, \$1,130.60 from Computer Equipment, \$2,510.10 from Advertising and \$10,491.00 from Retirement to Repairs in the total amount of \$20,249.20 to cover the cost of reimbursement for necessary shoring work associated with the purchase and redevelopment of the former Urban Renewal Agency-owned property at 253 Genesee Street.

The second transfer in the amount of \$2008.44 from Other Supplies & Materials, \$4,588.95 from Miscellaneous and \$250.00 from Office Equipment to Contracted Services to cover the cost of the 3-year financial audit of the Urban Renewal Agency conducted by the Bonadio Group.

Michael Mahoney made a motion to approve the first transfer to cover the cost of shoring work on 253 Genesee Street. The motion was seconded by Dave Farina and passed unanimously.

Michael Mahoney made a motion to approve the second transfer to cover the cost of the Bonadio Group's audit. The motion was seconded by Robin Harris and passed unanimously.

ITEM #4 Discussion: Rebuild Mohawk Valley Properties
