**DISTINGUISHING FEATURES OF THE CLASS**: This position exists in Urban Economic Development. This is the beginning level of professional planning work involving responsibilities to perform limited office and field assignments in connection with municipal, regional or community planning projects. Responsibilities include collected and analyzing data, preparing charts and other graphic materials and assisting with community planning projects and programs. The work is performed under general supervision of a higher level Planner or other supervisor with limited leeway allowed for independent judgment in carrying out details of the work. Does related work as required.

#### **TYPICAL WORK ACTIVITIES:**

Completes components of a variety of planning projects under supervision;

Collects data and participates in studies involving research, investigation analysis of sociological, economic and environmental factors related to municipal, regional and community planning;

Collects, analyzes and tabulates statistical data for use in population, housing, community development and land use reports;

Prepares charts, drafts, working drawings, designs, layouts to scale and other geographic materials to aid in the planning function;

Attends neighborhood, community development and housing/homeless meeting to offer staff assistance relative to community planning projects and programs;

Performs a variety of related tasks as required.
