<u>DISTINGUISHING FEATURES OF THE CLASS</u>: Assists in the inspection of dwellings to determine compliance with the Housing Code while undergoing on-the-job training. This classification applies to employees undergoing on-the-job training become qualified Housing Code Inspectors. Appointments are limited to one year during which time appointees are required to successfully complete a formal training program in Code Enforcement. Appointment to the position of Housing Code Inspector will be made without further examination upon successful completion of one-year training period. The work consists of elementary, routine tasks involving responsibility for learning and assisting in the inspection work of the Housing Code Enforcement agency. The work is performed under close supervision of a Housing Code Inspector and or Commission of Code Enforcement. Does related work as required.

TYPICAL WORK ACTIVITIES: (Illustrative Only)

Performs study and reading assignments;

Observes inspections and learns Housing Code inspection techniques and practices;

Assists in making inspections related to the Housing Code Enforcement program;

Assists in maintaining records and preparing reports;

Performs increasingly responsible duties as assigned.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES: Ability to learn basic principles, techniques and practices of Housing Code Inspection; ability to develop cooperative relationships with associates and the public; ability to develop skill in inspection techniques; ability to keep records and prepare reports; good power of observation; good judgment; tact, courtesy, and integrity; Physical condition to commensurate with the demands of the position.
