The bidder plans to use the properties for Religious Activity, food pantry, clothing distribution, Bible Summer Camp, and Community Service. A second offer was received from Shahin Ahmadov in the amount of \$95,000.00. The bidder plans to Occupy for Primary Residence, and to create a Tutoring Center.
