

This claim for City's share of sidewalks cannot be approved unless the sidewalks have been constructed in accordance with permit issued by the City Engineer in conformity with Sections 26 and 28 of Article 7, Chapter 658 of the Laws of New York, with certain revisions therefor made applicable by the enactment of Local Law No. 1, 1931, adopted by the Common Council on January 21, 1931, which provides that:

1. Claim must be filed within thirty days after sidewalks completed.
2. Claim must be accompanied by affidavit of owner of record and contractor or person in charge of work, setting forth that such work has been performed in accordance with the permit and that the cost thereof has been paid.
3. Claim must be accompanied by certification by the City Engineer that thy sidewalks have been constructed true to line and grade.
